Summary Report

All the public authorities should proactively disclose the information under the Right to Information Act, Section 4, which will help bring transparency in the administration. We appreciate the sincere efforts of the NITTTR, Chennai as a Public Authority for sharing required information on the website to maintain transparency.

During Auditing it is observed that the information related to few areas have to be shared on the website:

- The process flow to be defined for these services under “Norms for discharge of functions” under RTI Act.
- The information of Email id is missing in the “Directory of officers and employees” under RTI Act.
- The information such as designation, telephone numbers and email ID of CPIO is missing under “Name, designation and other particulars of Public Information Officers [Section 4(1) (b) (xvi)]”
- The official link for program details to be provided for Programmes to advance understanding of RTI under RTI Act.
- The information related to STQC certification, its validity and its appearance in the website is not available. Hence, it needs to be uploaded. It is suggested to take initiative to obtain Vulnerability Assessment Certificate, and the same has to be uploaded in the website.

It is suggested that the Public Authority of National Institute of Technical Teachers Training & Research (NITTTR), Chennai, may take necessary action to disclose the above discussed information on the website as per the Section 4 of the RTI Act.
