## TERMS AND CONDITIONS OF TENDER

1. All the bidders will have to submit sealed tender for the items on or before 09.07.2021(Friday) 3.00 PM at office of Director, NITTTR, CSIR Road, Taramani, Chennai - 600 113, the cover should be superscribed as quotation for "E-Waste".
2. The bidder should submit refundable deposit by Bankers Cheque / Demand Draft drawn in favour of The Director, NITTTR, payable at Chennai for Rs. 20,000/- which will be refunded to all unsuccessful bidders immediately after tender process is completed. The tender will not be considered without the refundable deposit.
3. The materials offered for bid is strictly on "AS IS WHERE IS BASIS". Hence, bidders should inspect the items before submitting the bid. They can visit NITTTR Chennai office premises at Taramani, Chennai - 600 113 and inspect the items kept in the identified places on any working day between 10 AM and 5 PM from 17.06.2021 to 08.07.2021.
4. All applicable taxes are payable by the buyer. However, the sales certificate will be issued by the NITTTR, if required.
5. The Institute reserves the right of accepting or rejecting any or all the bids received without assigning any reasons to the bidders. The decision of the Director, NITTTR, Chennai shall be final and legally binding on all bidders.
6. The Institute reserves the right to re-tender and / or conduct re-auction for any items.
7. The tenderer shall enclose a copy of the certificate of authorization issued either by TNPCB or CPCB. Others who do not possess are not eligible to participate in the tender.
8. The tender will be awarded to the bidder who quoted highest bid value.
9. The successful bidder is required to deposit the total bid value along with applicable taxes within two working days from the date of award of contract.
10. The items shall have to be removed by the bidder within 15 days from the date of issue of acceptance letter.
11. If the materials are not lifted beyond 15 days of issue of acceptance letter a ground rent of Rs.500/- per day will be charged.
12. The designated materials have to be lifted within maximum 30 days of issue of acceptance letter.

13. If the bidder fails to lift the material within a period of 30 days of issue of acceptance letter, the Director, NITTTTR reserves the right to re-auction or dispose of the said E-Waste in a manner, he deems fit.
14. The delivery of the auctioned material shall be taken on any working day from 10 AM to 5 PM.
15. In case, the bidder intends to take delivery of auctioned material through his representative, bidder shall give the letter of authority duly counter signed by him.
16. The NITTTTR will not take any responsibility for arranging export permit transport and wagon etc.
17. In the event of infringement of any terms and condition by the bidder, the Institute at its discretion, may forfeit the deposited money by the bidder.
18. If the bidder is found trying to negotiate with any institute employees for any undue benefit, whatsoever may be the reason, bidder will be debarred from participating in auction and deposit made by the bidder will be forfeited.
